I would like to declare my intent to participate in the College Credit Plus program.

- **I understand that signing this form does not require that I participate during the coming school year and I may decide not to participate without consequence.**
- I also understand that it is my responsibility to notify my school if I do not gain admission to my selected institution of higher education or choose not to participate for some other reason.
- **In addition, I certify that I have received counseling (outlined below) about the College Credit Plus program concerning the rules and regulations for both my school and the college, and that I understand my responsibilities, the benefits and possible risks of participating in the College Credit Plus program.**
 - I accept the rigor expected in a dual enrollment course. I expect substantial homework and the need to work outside of the school day, and I know that I cannot expect due dates to be adjusted for field trips, job shadowing, Career-

Technical Student Organization meetings, weather delays, school closings, etc. I understand that it is to my advantage to submit work early to avoid missing important deadlines.

- I understand that Internet access outside of school may be critical to success.
- I understand that participating in a College Credit Plus course begins my child's college transcript.
- I understand that the dates to drop College Credit Plus classes without financial or academic penalty vary based on the associated college or university. These dates will be communicated to students during the first class meeting and will be listed on the course syllabus.
- I understand that Miami Valley Career Technology Center is paying the tuition for College Credit Plus courses. If my child withdraws from the dual enrollment course after the 100% refund drop date, withdraws from MVCTC during the semester, or fails the dual enrollment course, I agree to repay that tuition. If necessary, these fees will be added to my child's MVCTC student fee account, and I know my child's grades and credit cannot be released to my child's home school until payment is received in full. It will be the decision of the home school whether to allow seniors owing fees to participate in graduation exercises. Failure to make payment may affect your child's eligibility to receive final high school transcripts.
- I understand that private colleges and universities as well as public colleges and universities outside Ohio may not accept credit for these courses through transfer. It is the parent/student's responsibility to check with colleges they are interested in to verify the credit will transfer.
